



## **Eligibility Statement**

Our primary focus is on supporting current matriculated students, post-doctoral researchers and recent graduates of the university – in particular those who graduated within the last 12 months. If you meet these criteria, you are likely to be able to benefit from our full range of support which you can access through our Careers platform, Handshake.\*

Those who graduated from the university more than 12 months ago can also make use of the service via Handshake, though one-to-one appointments are limited to the vacation period. This is to ensure that we can offer sufficient support to current students at the busiest times of year. ## **Key to Access Levels.**

- 1: Able to view vacancies & careers resources via Handshake. Eligible to attend Careers Service events & one-to-one appointments.
- 2: As above. Appointments bookable outside term time only.
- 3: Able to view vacancies and some resources & events.
- 4: Public content only (Web content, YouTube, Blog, Social Media).

## **Notes**

- a. Judge Business School (JBS) Master of Accounting, Master of Finance, MBA and Executive MBA are Level 3. Other JBS students are Level 1
- b. Where more than one criterion apply, eligibility is based on the higher access level (e.g. a former Postdoctoral Researcher who was previously an undergrad at Cambridge is Level 1)
- c. Current staff who do not also meet Levels 1 or 2 must register on Handshake with an @cam.ac.uk address
